## Hurricane Helene & FEMA Update from Town Manager Reeves

---

### September 27th:

Western North Carolina was devastated by Hurricane Helene.

### October 15th:

The first step was to record what and where damage occurred. An inventory of damage was drafted by Town Engineer Buie for public roads and infrastructure. The Town's initial estimate was between \$5 and \$10 million dollars. For reference, the annual operating budget for the Town of Laurel Park is roughly \$4.6 million dollars. With numbers like these, the Town found itself ***completely*** dependent on public assistance from other government agencies to fund these permanent repairs.

### November 12th:

The first visit by FEMA and NC Department of Emergency Management (NCEM). This meeting kicked off the Town's recovery efforts. We were just discovering how the wildly complicated process would look, and the required steps ***if*** the Town were to seek reimbursement from the federal and state government.

### December 2nd - 6th:

***Laurel Park was the first municipality in the region to set up and have site site inspections.***

FEMA and NCEM began site inspections which, is the prescribed next step for funding eligibility. Out of the 56 mapped areas, we only scratched the surface by visiting 16 within that week. Accurate identification of the damages and repairs needed is the foundation to establishing the amount of funding requested from FEMA and NCEM.

The new year came and went without the state or federal government providing cash flow via grants, loans, or funds for the region to begin building.

**January 3rd:**

The Town requested proposals for engineering services. The award granting took longer than anticipated because of federal and state procurement policies. The next step is having the engineers draft scopes of work for repairing and mitigating each and every damaged area.

**February 17th:**

The Town requested proposals for landscape architecture services. Once we have this contract secured, we can begin assessing and estimating repairs for the parks and municipal buildings.

The Town scheduled 15 more site inspection dates for February and March. Something important to note here is that FEMA site inspection can only occur every other weekday.

**February 24th:**

The Department of State Treasurer announce the first round of interest-free loans for Hurricane Helene relief to local governments and more checks from that tranche are forthcoming soon. I am proud to report that Laurel Park applied in time and received about \$1.5 million dollars to begin addressing some of the areas that are affecting life, safety, and property.

Those brief highlights bring us to today. We hear and understand the frustrations from our community. What I want to announce is simple: Your Town staff and officials are doing everything in our power to restore our beautiful town on a mountain. Unfortunately, we are at the mercy of funds that are not in our coffers. Cities and towns across Western North Carolina continue to face tremendous challenges rebuilding from the devastation wrought by Hurricane Helene, and most of us are dealing with financial hurdles as a result. Even as federal and other state resources are made available over time, municipalities have expenses that must be paid now to help residents recover. The average reimbursement time for FEMA is 632 days. I will give that a moment to sink in because this is proving to be the biggest hurdle yet. Every step of progress is slow, but meaningful. If Town staff and contractors are not careful to follow all of FEMA AND NCEM's requirements, the Town's public assistance request will be denied, and our taxpayers would be liable for making up the difference.

Please respect the challenges your community leaders face with unprecedented financial constraints and staff capacity as they relate to service demands.

**SIMPLE STEPS FOR BUYING BEE-SAFE PLANTS**

- 1 Seek out organic plants and seeds.
- 2 Avoid plants grown with neonicotinoids and other similar systemic insecticides.
- 3 Ask what steps your nursery takes to offer plants grown using pollinator-friendly pest management.

Are you planting a pollinator garden? If so, talk to your nursery about pollinator-friendly practices. Many nurseries commonly use pesticides, some harmful to bees. Take the time to let your nursery know you want plants free from harmful pesticide residues.

## Rhododendron Lake Nature Park

Hurricane Helene inflicted significant damage upon Rhododendron Lake Nature Park, including the infrastructure and natural features of the park.

FEMA is our primary partner in the assessment of damage and funding for the restoration. The Town is awaiting final analysis from FEMA before any active restoration efforts may begin. FEMA has not provided a timeline for completions of these tasks.

As we await a final FEMA assessment, Rhododendron Lake Nature Park remains closed due to unsafe conditions. When and if the Parks & Greenways Board receive relevant updates from FEMA, we will ensure that information is communicated to the residents of Laurel Park. Please do not enter the park as the trails are unsafe and the ground is unstable.

# Invasive Species Committee



Invasive Plant Observation  
Sweet - Breath - of Spring  
*Lonicera fragrantissima*  
Honeysuckle family



As of February 8, this shrub species from the Honeysuckle family, has started blooming in Laurel Park. It is very fragrant and is listed as an invasive by the NC Invasive Plant Council. ## Influence of Hurricane Helene on Invasives

The increase in sunlight and open ground due to tree/canopy loss, provides fertile ground for invasive vine to infest. As trees fell, fragments of vines have spread with the potential to reestablish in the spring. As warm weather approaches, be on the lookout for new infestations of English ivy and other invasive vines.



## The “Why” of Invasive Vine Removal

Laurel Park is home to many native species including trees, understory shrubs/bushes, and small, rare herbs. The aggressive growth of invasives is a threat to our native plants. Unchecked, the invasives can become the dominant species in our plant communities and reduce the populations of desirable and rare plants.

Identification and classification of native/non-native plants in Laurel Park is a key first step in management of invasives. **The leading cause of home clothes dryer fires is failure to clean them!**

Clean the lint filter before or after each load of laundry. Remove the lint that has collected around the drum.

Keep the area around your dryer clear of things that can burn, like boxes, cleaning supplies and clothing.

**Most cooking fires in the home involve the stovetop!**

Keep anything that can catch fire - oven mitts, wooden utensils, food packaging, towels, or curtains away from the stovetop.

Always stay in the kitchen when frying on the stovetop.

**Extension cord fires outnumbered fires beginning with permanent or detachable power cords by two-to one!**

Check electrical cords to make sure they are not running across doorways or under carpets. Extension cords are intended for temporary use.

Have a qualified electrician add more receptacle outlets so you don't have to use extension cords.
