# FROM MAYOR CAREY O'CAIN

#### **POSITIVE PROGRESS**

I must admit that we live in a Special place.... thanks to the vision of W. A. Smith over 100 years ago. These Precious assets that we inherited are being preserved by this Council, as have previous Councils. We could choose to minimalize the needs for improvements, but we have chosen to continue to emphasize how great Our town is.... Just as W. A. Smith would have wanted.

#### **ROADS, ROADS, ROADS!**

Over five years ago your Council dedicated an additional 3 cents of our tax rate to road improvements. After consulting with our civil engineer, we have determined that it is necessary to increase this commitment in order to get ahead of the road deterioration curve. Last year we budgeted 1 million dollars to road improvements. This year we have committed an additional \$700,000 to roads. By bundling these commitments, we were able to acquire more competitive bids. Fortunately, prices of oil have also lowered over last year's prices. We received bids in June with the expectation of completing this work before winter. *You will see an impact*.

For the foreseeable future, we anticipate spending between \$400,000 and \$600,000 annually on road improvements. With this dedication, our consultants believe that our Town will be ahead of road deterioration by 2029. Bicyclist and motorist will recognize the differences soon.

#### STORM WATER AND EDGE-OF-ROADWAY IMPROVEMENTS AND REPAIR

Thanks to a Grant of over \$700,000, we are able to improve our storm drainage and edge-of-roadway. This work was contracted in May, work commenced in June and will be complete this fall. This work MUST precede the paving work.

#### STREAM RESTORATION AT LAUREL GREEN

Laurel Green Park closed in May and will reopen later this summer. Work on this park mitigates further erosion and allows for proper handling of potential flood waters while maintaining an inviting and friendly play area for children. We owe a tremendous thank you to our Representative and now state Senator Tim Moffitt for his help in procuring grants to cover the majority of these costs.

#### **INVASIVE VINES**

As you drive the main roads in Town, please observe the results of our efforts to remove invasive vines within the easement. Thanks to a generous gift, we are making vast improvements to the future protection of our beautiful forest. Please follow this example on your own property and protect your trees. Should you need guidance please call Town Hall.

#### **PARKS AND GREENWAYS**

Our Parks and Greenways committee is fabulous. They have helped improve Laurel Green, Rhododendron Lake Nature Park, Glenrock Spring, Jump Off Rock, trails, pollinator gardens and Town Hall. They have designed, planned and planted with volunteers. They have supervised many Eagle Scout projects, all for the benefit of Laurel Park. Please thank any of the many volunteers every chance you have.

#### **FRIENDS OF LAUREL PARK**

FLP helps make our Town special with organizing events including concerts, yoga, special events and roadway cleanup events. This group is a non-profit that operates independently from our Town, and we are very appreciative of their contributions over the years. Please support this amazing group of volunteers.

#### **FIRE PROTECTION**

Our fire department, Valley Hill Fire Protection, maintains the best rates and the best service within Henderson County. They recently achieved an excellent ISO rating of 2 which means lower insurance rates for our property owners. We are so lucky to have their protection.

#### **HIGHWAY 64 IMPROVEMENTS**

This time next year expect construction to have commenced on Highway 64. DOT is currently in the land acquisition phase. Council has been setting aside funds to support landscaping, sidewalks and visually enhancements that DOT excludes.

#### **TOWN HALL**

Plans for a new Town Hall are currently on hold.

#### **DEVELOPMENTS**

Several developments are proceeding. Ecusta Crossing near Hawthorn Hills is underway with eight duplexes nearing the finish stage. Laurel Heights Retirement Center, a 133-unit facility at Highway 64 and Glasgow, expects to commence in 2024. The Coates Plant closed January 1st. Soil testing is underway and there are several interested parties, so expect an announcement soon!

#### **PROPERTY TAX RE-EVALUATIONS**

The County Tax Assessor's office re-evaluates property values every 5 years. Laurel Parks property values have increased substantially. The Median house listing price in Laurel Park is about \$450,000. The tax value is usually less than the listing price. Our new tax rate is 39.5 cents. Thus, the average tax bill based upon the average listing value would be \$1,778 annually. Considering the services that Laurel Park provides residents (trash, brush pickup, police, roads, snow removal, parks maintenance), I'm happy to contribute. If I lived within the City of Hendersonville, I would pay a rate of .49 cents. I'll happily pay the lower rate and live in this Wonderful Town.



Most of the Town's revenue is collected from property taxes and taxes on motor vehicles, and sales taxes.





### **Friends of Laurel Park**

The Friends wish to give hearty thanks to all our loyal donors and sponsors. As of June 12, we have had contributions from 12 local sponsors and 119 donors, and we acknowledge them at our public events.

The Friends of Laurel Park have scheduled a very full agenda for 2023. In February, we began with our first winter indoor concert featuring Laurel Park musicians John Perkins and Joel Helfand. The free music series continued with Jump Off Rock concerts in April, May, and June, with a record crowd at the June event with the Asheville Jazz Orchestra.

Coming up on September 16, Two Step Too will return to Jump Off Rock, and our final concert will again feature Autumnwud on October 6. Details to follow.

In addition to music, we included a workshop in March led by Will Coffee on vine control on our Laurel Park trees, a continuing threat to the health of our forests. The town supports two part-time men to work on town-owned roadsides to control English ivy, wisteria, kudzu, and nonnative grape.

On July 25th, the FLP has invited Chris McDowell from the Valley Hill Fire and Rescue station on Stepp Drive to give a remedial class on CPR for interested residents. It will run from 3 to 5 pm. You never know when you might be called upon to save someone's life!

The second annual "Historical Tour of Laurel Park" will take place on Saturday, August 19 with bus tours operating at 9 and 11 AM, led by local historian Knox Crowell. Look for more details later, but space may be limited.


The FLP members work in cooperation with the town's Parks and Greenway (P&G) committee on the maintenance and improvement of walking footpaths throughout the town. Also, the P&G committee is seeking volunteers for footpath work as it arises.

Planning has been underway for a year already for the 2025 Centennial Celebration of the Town. Board member Jim Wilson has been a major player in developing ideas and exploring funding options for a variety of events, ranging from music to historic home tours to a gala event, and more.

In addition, Board members plan nature walks, assist in the Town's Trunk or Treat event, and hope to include a recycling education meeting later in the year.

A Jetter from Your Neighbor

I was born in Hendersonville and grew up in Laurel Park. I left home 47 years ago for college and to begin a career and work life. After retiring in 2020, it has been a joy to return to Laurel Park. Much has changed through those many years and most of that change has been very good, making Henderson County an even better place to live for those raising families, retiring, or just getting started in life. I am grateful for the significant contributions made to my hometown by the many new residents who have come to Hendersonville, and for the overall good stewardship provided by elected officials and all those working to move the community forward.

One change that is unwelcome however, is the spread and proliferation of vines and other invasive plant species that pose a real threat to the natural beauty and environmental vitality of our region, and specifically to the mountain forest that is Laurel Park. The little block where I grew up has been devoured by bamboo and ivy hanging from almost every tree. I am aware that some people are of the opinion that ivy climbing tree trunks or hanging from branches is attractive, but vines harm trees by competing with them for nutrients from the soil, providing sanctuary for tree harming insects, obscuring the natural beauty of a tree trunk, enveloping the canopy and killing the tree. Weakened trees fall, with the risk of personal injury, property damage and the disruption of key services.

Trees contribute much to the environmental quality of Laurel Park by adding to the character of the town and enhancing the quality of life on the mountain. Trees are critical to slope stability, create wildlife habitat, adding to the aesthetic of the community, and preserving and increasing property value!

The Town leadership is aware of this real, evolving threat and has offered several seminars on dealing with invasive species. A concerned resident has made a generous financial gift to underwrite the clearing of town property and rights-of-way of tree-climbing vines. As most of our trees are on private property, Laurel Park will still be awash with trees that are at risk from ivy and other tree climbing vines. Preserving and saving our Laurel Park forest is absolutely and totally dependent upon the initiative and action of individual property owners.

Please consider joining Town leadership, volunteers and individual property owners who love and value our Laurel Park forest and are taking action with some degree of urgency to check and contain the threat that tree climbing vines pose to all of our trees.

#### **BASIC SUMMER HEAT SAFETY TIPS**

Valley Hill Fire & Rescue encourages everyone to follow these basic heat safety tips in order to avoid the dangers of heat exposure this summer.



- During the hottest hours of the day, stay inside. If possible, stay inside an air-conditioned building.
- Drink plenty of water. Dehydration can occur if you do not drink enough water.
- Avoid drinking alcohol and beverages that contain caffeine.
- Keep blinds and curtains closed from morning until the late afternoon to block extra direct heat from sun light.
- Seek medical care right away if you become nauseous, start vomiting or experience cramps.
- Use a fan. Don't place the fan directly in front of a window because it may push hot air in. Try placing the fan so that it blows in the room and out the window instead.
- Never leave a person or a pet in a car in hot conditions. People and pets can succumb to heat exposure, which could lead to heat stroke or even death. Cars can become overheated quickly. It's never safe.




