Summary of Item: As a result of the COVID-19 pandemic, the Town received ARPA funds in the amount of \$742,565.04. That sum was appropriated Coronavirus State and Local Fiscal Recovery Grant Project Fund, with 100% of the funds budgeted to invest in stormwater infrastructure. Currently, we have \$158,371.25 left of those funds. Town Manager Reeves and Financial Consultant Burleson recommend the Town Council transfer the remaining funds to the budget line C of the grant project ordinance to provide for government services

ORD 2022-5

Grant Project Ordinance for the Town of Laurel Park Coronavirus State and Local Fiscal Recovery Funds

BE IT ORDAINED by the Town Council of the Town of Laurel Park, North Carolina that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following grant project ordinance is hereby adopted:

Section 1: This ordinance is to establish a budget for a project(s) to be funded by the Coronavirus State and Local Fiscal Recovery Funds of H.R. 1319 American Rescue Plan Act of 2021 (CSLRF). The Town of Laurel Park received the first tranche on July 13, 2021 in the amount of \$371,282.52 of CSLRF funds. The total allocation is \$742,565.04, with the remainder to be distributed to the town within 12 months. These funds may be used for the following categories of expenditures, to the extent authorized by state law.

- A. Support public health expenditures, by funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff;
- B. Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector;
- C. Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic;
- D. Provide premium pay for essential workers, offering additional support to those who have borne and will bear the greatest health risks because of their service in critical infrastructure sectors; and,
- E. Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet.

Section 2: The following amounts are appropriated for the project and authorized for expenditure:

- A. Support public health expenditures, by funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff; \$0
- B. Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector;

C. Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic; \$0 D. Provide premium pay for essential workers, offering additional support to those who have borne and will bear the greatest health risks because of their service in critical infrastructure sectors; and, \$0 E. Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet. \$742,565.04 Total CSLRF Project \$742,565.04 **Section 3:** The following revenues are anticipated to be available to complete the project: **CSLRF Funds** \$742,565.04 Section 4: The Finance Officer is hereby directed to maintain sufficient specific detailed accounting records to satisfy the requirements of the grantor agency and the grant agreements. Section 5: The Finance Officer is hereby directed to report the financial status of the project to the governing board on a quarterly basis. Section 6: Copies of this grant project ordinance shall be furnished to the Budget Officer, the Finance Officer and to the Clerk to Town Council. Section 7: This grant project ordinance expires on December 31, 2026, or when all the CSLRF funds have been obligated and expended by the town, whichever occurs sooner. 

PROJECT SUMMARY

The Above the Mud project will provide multimodal infrastructure that will spur small-town economic development, jobs, and tourism while rebuilding a trail segment damaged by recurring flooding and Hurricane Helene. The project will extend the 19-mile regional Ecusta Trail that is expected to generate significant rural economic impact, bringing residents and tourists safely into Downtown Hendersonville. It will also reconnect to underserved neighborhoods, improving safety and access.

This project focuses on creating a loop of multimodal transportation access, ultimately connecting three major developing regional trail systems. The infrastructure effort will make Hendersonville a hub and beacon of tourism and economic activity. The project will reconnect historic black neighborhoods, build new connections, improve existing greenway impacted by recent flooding, and rebuild an aging three-block stretch of South Main Street, near the Ecusta Trail, as a regional activity hub and Festival Street that directly connects Downtown Hendersonville with the regional trail network.

Components of this project include:



Location

City of Hendersonville, North Carolina



Total Mileage

2.58 miles of improvements

Including improved safety, increased accessibility, multi-use paths, sidewalks, streetscape improvements, pedestrian-friendly streets, and strengthened climate resiliency.



COMPONENT 1

'Above the Mud' Trail

A 1.56 mile separated shared use pathway for bicyclists and pedestrians through natural areas, connecting the Oklawaha Greenway to the regional Ecusta Trail, future Saluda Grade Trail, and downtown Hendersonville.



COMPONENT 2

7th Avenue Streetscape Improvements

A safe and walkable .41 mile connection between northeastern neighborhoods and downtown with improved sidewalks, lighting, green infrastructure, pedestrian amenities, and ADA compliance.



COMPONENT 3

Festival Street

A .28 mile pedestrian-focused street and flexible event space catalyzing economic development for businesses, with limited automobile access, connecting downtown to three regional trails.



COMPONENT 4

Oklawaha Greenway Boardwalk (on existing trail)

A .33 mile elevated boardwalk, retrofitting the current trail to be a safer and stormwater resilient trail connection for pedestrians and bicyclists along the Oklawaha Greenway.

A vibrant, safe, and active community, through street and trails that prioritize pedestrians and bicyclists and serve users of all ages and abilities.



Greatly improved access to downtown, disadvantaged neighborhoods, schools, food, businesses, and parks and natural areas.



More livable, resilient streets that use trees and stormwater best practices to shade, clean the air and water, and better manage flooding.



Economic revitalization by connecting a critical regional trail link and improving 7th Avenue and South Main Street.
