## **Town of Laurel Park - Public Notice**

This notice is being sent to you because you own a property adjacent to a property subject to a Board of Adjustment hearing under the Unified Development Ordinance (UDO).

The following items are scheduled to be addressed by the Laurel Park Board of Adjustment on Thursday July 11<sup>th</sup> at 4:00 PM at the Laurel Park Town Hall. You are invited to attend in person or view the hearing online via Zoom. You can view online via Zoom; however, you must be physically present at the Laurel Park Town Hall if you plan to voice any concerns or recommendations.

Ingles Markets is requesting a variance for signage at 1725 Brevard Road. The specific lots are further identified on the records of the Henderson County Mapping Office as PINs 9559807145 & 9559809349. The lots are in the Town Center zoning district, with an estimated acreage of 9.16 acres.

NCDOT required Ingles Markets to move the existing Monument Sign which is 19 feet 8 inches tall and has a total sign area of 232.5 square feet. Per Table 7.8.7: Signage Standards, Monument Signs are limited to 8 feet in height and no more than 48 square feet. Section 5.3.2 Continuation and Replacement subsection C Relocation states the following:

A nonconforming structure shall not be moved, in whole or in part, to another location on the parcel of land on which it is located, unless the relocation removes or reduces the nonconformity.

The hearing shall be conducted, and this notice is given, pursuant to the Rules of Procedure for the Laurel Park Board of Adjustment. A copy of the Rules of Procedure, together with a copy of the Application for Variance, may be obtained by contacting the Assistant to the Town Manager at Laurel Park Town Hall, 441 White Pine Drive, Laurel Park, North Carolina, (828) 693-4840. Office hours are Monday – Friday, 9am – 5pm.
