Tax Collector's Report (November 30, 2024)

For prior year taxes, a total of \$28,873.59 remains outstanding. The Town received \$798,344.90 from Henderson County for property taxes collected for August and a total of \$1,556,170.87 since the 2025 bills were mailed. The 2025 tax levy is \$2,626,895.57. The Town currently has a collection rate of 59.418%.
