

Town Council Work Session Minutes January 12, 2023 – 9:30 a.m.

APPROVAL OF THE AGENDA

Town Manager Carmichael amended the agenda to include the Legislative Goal Statement. Mayor Pro Tem Hansen moved to approve the amended agenda. Mayor O'Cain asked for discussion; there was none. The vote was unanimous in favor of the motion.

OLD BUSINESS

BOARD AND COMMISSION APPLICATIONS- PLANNING BOARD

Town Manager Carmichael said the Planning Board recommends Ms. Licisyn for the open position.

Mayor Pro Tem Hansen moved to appoint Ms. Mary Margaret Licisyn to the Planning Board for a 2-year term ending December 31, 2024. Mayor O'Cain asked for discussion; there was none. The vote was unanimous in favor of the motion.

JUMP OFF ROCK GRANT

Assistant to the Town Manager Jordan Jones said Staff has been in communication with Henderson County Tourism Development Authority (TDA) to seek additional funding for the Jump Off Rock parking lot refurbishment. TDA staff would like to know if the Town could appropriate at least 50% of the project cost of \$20,000 or if not, what amount could the Town contribute. The TDA board will meet January 24th.

Council decided the Town will appropriate an additional \$5K more and accept the TDA match of \$10K.

Mayor O'Cain conducted Oath of Office to Mayor Pro Tem Hansen.

NCLM- GOAL STATEMENT

Town Manager Carmichael said the NCLM would like Council to appoint a member to submit an online ballot for their goal statement.

Commissioner Bridges had highlighted in red 10 statements she thought were more specific to Laurel Park.

Mayor O'Cain suggested keeping "Update annexation petition thresholds to make voluntary annexation easier to initiate" and removing "Provide local revenue options beyond property tax." Mayor O'Cain moved to appoint Commissioner Bridges. Mayor O'Cain asked for discussion; there was none. The vote was unanimous in favor of the motion.
