Ms. Denise Layfield said the Laurel Green Playhouse is over 20 years old and needs maintenance. There is a beam that needs to be addressed urgently.

Ms. Layfield suggested having Mr. Ken Gaylord take control of the project and he would be able to find a subcontractor and manage this project for the board.

Mr. Anderson said the board had put \$5k aside for the Laurel Green and is asking the Council to pay the rest.

Mayor O'Cain said to get a proposal together by Tuesday's meeting of the Council and then they can move forward from there.
